## 2026 Supplemental Benefits

## **DBS Flexible Spending Account(s)**

- Employees <u>must</u> enroll and set their annual contribution limits each year
  - Failure to enroll and set annual contribution during AE will result in no FSA benefit for the 2026 Plan Year.
- \$2.24/month Administrative Fee
- Healthcare FSA maximum contribution limit: \$3,400
- Dependent Care FSA maximum contribution limit: \$7,500\* (\$3,750 if married and filing separately)
  - \*Highly Compensated Employees' (HCE), defined by the IRS as someone who earned \$160,000 or more in the prior year, dependent care maximum remains at \$5,000.



## What Can You Do During AE?

- Health, Dental, Vision, Critical Illness, Accident
  - Enroll, switch plans, make changes to your dependents, or cancel during Annual Enrollment.
- Pet Insurance, Identity Protection, AD&D
  - Enroll, switch plans or dependents, or cancel at any time during the year.
- Long Term Disability, Long Term Care, OGB Life
  - If you are <u>not currently enrolled</u>, you may apply with Evidence of Insurability (EOI).
  - To cancel current coverage, please email <u>benefits@lsu.edu</u>.



## What Can You Do During AE?

#### UHC Term Life Insurance

## Employee


- <u>Currently enrolled</u> may increase coverage by \$10,000, up to the maximum limit, with no Evidence of Insurability (EOI).
- Not currently enrolled may elect \$10,000 with no EOI.

### Spouse

Spouse <u>must submit EOI</u> and be approved for any coverage or increase

#### Child(ren)


 Child(ren) can be enrolled in any level of coverage as long as employee is covered. EOI is not required.





## What Can You Do During AE?

- Flexible Spending Account(s) and Health Savings Account
   Contributions
  - You <u>must</u> enroll and set your annual contribution, regardless of your current enrollment,
    - FSA: Failure to enroll and set annual contribution during AE will result in no FSA benefit for the 2026 Plan Year.
    - HSA: Employees must re-elect their contributions each year but can make changes to their contributions anytime.







provides personalized guidance to connect you with resources for childcare, parenting, school and financial aid, caregiver support, and even home repairs.


